As mentioned in the aforesaid letter dated 19.05.2023, the GGSIPU has examined the JAC report/inspection report in respect of the above Institute. The same has been perused and it has been noticed that Part-I of the JAC report is more relevant in respect of land issues and statutory compliances of the institute and remaining Part-II & III of JAC report is related to academic matters including infrastructure and status of compliance with other terms and conditions pertaining to Institute. It is presumed that the JAC headed by Retd. Senior Officers, other subject experts and representative of University as members has seen and examined all the relevant documents/statutory clearances as per policy guidelines issued by this Directorate during the inspection and recommendations have been made in accordance with Policy Guidelines.

However the JAC has pointed out non availability of following statutory clearances in respect of the aforesaid institute:

- I. Cadre ratio in faculty is OK for B.Ed but needs improvement in BCA Programme.
- II. Efforts required for improving publications of the faculty members. Faculty needs to be inspired for this purpose.
- III. There is improvement in workshops/seminars for students but it needs to be encouraged more in this area.
- IV. As advised in last Academic Audit the Institute may take initiative to publish its own journal /magazine.
- V. There are two "ad-hoc system in practice for faculty in BCA & B.Ed courses. Some faculty members are shown as regular but no proof given in next JAC /Academic Audit, this needs to be rechecked.
- VI. In Library, there is need for more reputed journals & magazines to be subscribed. No system of maintaining record Log book for photocopy machine use. Library regulations need further improvement.
- VII. Accessibility e.g. Lifts, ramps satisfactory.
- VIII. More efforts will be appreciated for placements.
 - IX. Computer Lab for BCA good but there is non-satisfactory position for B.Ed. Labs.

X. <u>LAND</u> As per Inspection report, the Institute working /assets are satisfactory but there are problems in land bifurcation, fire safety, rain water harvesting issues. A separate attachment on land issues signed by all Members is given here. Institute needs to comply with undertaking given by it. Further action may be based on same.

In pursuance of the approval given by the Hon'ble Lt. Governor, Delhi to the institute to run existing approved courses from non-conforming areas/School premises during the current academic Session 2023-24, the Institute is directed to comply with fulfillment of other conditions and statutory compliances. The Department/ University may ensure that the Institute adheres to all statutory compliances in a time bound manner

Therefore, considering the facts above and based on the recommendations of JAC and GGSIP University, the provisional NOC for the following course for the Academic Year 2023-24 is granted to <u>Kalka</u> <u>Institute of Research and Advanced Studies</u>, subject to the following terms and conditions :

- h. The GGSIP University must ensure the compliance of the same within stipulated time period.
